- Call to Order and Establish a Quorum Patrick Just called the meeting to order at 5:00 PM and began recording. A quorum of 7 voting members was present.

- 3. Presentation by the Rockwall ISD Student Services Better Together TEA Character Trains per Texas Education Code 29.906

Rockwall ISD Counselor and Student Support Coordinators Kiala Albright, Missy Wall, and Rochelle Eddy presented Better Together which is designed to enhance curriculum, including tools for educators to incorporate TEA character traits into their lessons regularly. The BT Weekly one-page newsletter is emailed to all staff and includes resources and lesson ideas for educators PK-12 on character traits, restorative circles, staff wellness, music playlist, Positive Behavior Interventions and Supports (PBIS), and links to resource-rich wellness dashboards for elementary and secondary. SHAC members discussed ideas to increase the use of the BT Weekly by staff. Linda Mitchell Duran made a motion to present BT Weekly to the Board of Trustees for district-wide implementation. Amber Woodfield seconded the motion. Approved unanimously.

4. House Bill 3908 "Tucker's Law"

Patrick Just presented requirements for fentanyl education, including SHAC duties to recommend appropriate grade levels and curriculum regarding opioid danger, addiction, abuse, fentanyl abuse, and methods of administering an opioid antagonist. The Curriculum and Instruction (C&I) department is currently working on resources to present before the end of 2023-24 year to comply with this requirement and plans to create a team to write a local program for 2024-25 and beyond.
